INTUITION CORPORATE TRAINING SDN BHD, represented by

acting on the basis of the Charter, on the one hand, and SINGAPORE INTERNATIONAL SCHOOL (hereinafter referred to as SIS), represented by Director Dr. T.A.Khasanov, acting on the basis of Charter, hereinafter referred to as the Parties, have concluded this Memorandum on the following:

2. Subject of the Memorandum

- 2.1 The purpose of this Memorandum is the intention of the Parties to cooperate and develop teaching methods and experience exchange;
- 2.2 For the purpose of mutual cooperation, the Parties intend to implement joint projects in the field of teaching and learning processes.
- 2.3 The Parties intend to cooperate in order to provide mutual support and favorable conditions for the education of SINGAPORE INTERNATIONAL SCHOOL students and improve the quality of teaching at the SIS.

3. Obligations of the Parties

- 3.1 The obligations of the Parties include:
- Providing all possible assistance in establishing cooperation in areas of mutual interest;
- Organizing joint symposia, seminars, conferences, round tables, and other initiatives in the field of the key areas of activity of the Parties;

- Implementation of joint projects and programs;
- Cooperation in the training of highly qualified personnel and specialists in areas of mutual interest;
- Inviting representatives of the Parties to give lectures, exchange experience and information;
- Placing links to the websites of the Parties in order to inform about the events held;
- Informing the Parties about upcoming international conferences, seminars, exhibitions and fairs in the field of education organized by the Parties;
- Advanced training and professional retraining of the pedagogical staff of the Parties, if it does not contradict the statutory tasks of any of the Parties;
- Providing practical assistance in organizing and conducting scientific and practical seminars, business meetings, in order to ensure integration into various fields of science, education and practical application of the acquired knowledge and skills;
- Providing students with the opportunity to complete an internship with possible registration in the main staff;
- 3.2 The Parties voluntarily assume the obligation to fulfill the terms of this Memorandum, recognizing this document as the fundamental one in organizing the work of the Parties;
- 3.3 The Parties jointly develop proposals for priority areas of activity and submit them for discussion and decision-making;
- 3.4 Documents aimed at achieving common goals are mandatory for both Parties;
- 3.5 The Parties inform each other about the decisions and the amount of work done.

4. Responsibility of the Parties

- 4.1 A Joint Commission will be created by the persons who signed this Memorandum, consisting of at least one representative from each Party, who will be responsible for the implementation and further development of the plans of this Memorandum;
- 4.2 The Parties monitor the activities of the partnership on the issues set forth in this Memorandum at least once a year;
- 4.3 The Parties confirm their intention to carry out agreed actions to implement this Memorandum and achieve the goals specified in the statutory documents of both Parties.

5. Term and Termination of the Memorandum

5.1 This Memorandum shall enter into force upon its signing by the Parties for a period of 10 (ten) years and shall be valid until its termination;

- 5.2 The Memorandum may be terminated early at the initiative of any of the Parties. The Party intending to terminate the Memorandum shall notify the other Parties in writing no later than 15 working days before the date of the intended termination of the Memorandum;
- 5.3 If none of the Parties has expressed an intention to terminate the Memorandum upon the expiration of its validity period, the Memorandum shall be automatically extended for the next year.

6. Final Provisions

- 6.1 This Memorandum is written in the English language. Any future translation will be equal in establishing the mutual obligations of the parties.;
- 6.2 All changes and additions to this Memorandum shall be made in writing and signed by both Parties;
- 6.3 Nothing in this Memorandum shall create binding obligations that may not be overridden by unilateral decisions reflecting financial or other circumstances confronting any of the parties to the agreement.
